#### **WEMO**

#### SHEEP GRAZING PRESENTATION – Pricilla Watson

+ Slide show presentation on the sheep grazing permitting process; Pricilla described how AUM's are estimated by using a standardized grid and collecting the seeds and drying them. Currently there are 9 allotments and 20 active permits. The grazing period 1 March to 1 June, 2023. A letter of appreciation for her presentation is to be written by Chair Dunn

#### **DUMPING**

+ Dana Stephenson noted that illegal dumping has increased along with complaints. She noted, it's increasingly hard for BLM to press charges again individuals or groups responsible for the dumping; even when strong evidence is present. When complaints are received BLM follows up with a site visit and attempts to locate the source. Common practice is to have the Offender clean-up the affected site.
